AN ORDINANCE

Amending the 2018 Liquid Fuels Fund budget to accommodate the reclassification of three (3) part-time Maintenance Worker II positions to two (2) full-time Maintenance Worker II positions in the Department of Public Works.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ALLENTOWN:

SECTION ONE: That page 324 of the Liquid Fuels Fund budget be amended by deleting the temporary wages for three part-time Maintenance Worker II (8M) positions and adding two full-time Maintenance Worker II (8M) positions budgeted at annual salary of Forty-Four Thousand Forty-Five (\$44,045) Dollars.

SECTION TWO: That City Council authorizes the transfer of funds into Permanent Wages and FICA accounts as follows:

Bill would facilitate a small reorganization of Public Works positions and improve day to day operations at the Streets Bureau

The purpose of this bill is to create (2) full-time MW2 positions in Public Works in Liquid Fuels.

As opposed to the PT positions, the full-time MW2 positions will provide full year-round assistance and will not be limited to 25 hours per week. The MW2's primary function include performing a wide variety of duties involved in the construction, surfacing and repair of city streets, roadways, alleys and other surfaces, and snow maintenance throughout the city.

Per wage scale in the current budget book, an MW2 at the middle step of the bargaining scale (8M-D) is budgeted at \$44,045. We estimate the jobs will be fill sometime in July. The funds necessary for each position is figured at \$22,795 for salary and FICA.

Funds currently budgeted for three positions is \$52,533.00, leaving \$6,943 remaining in the Temporary Wage account.

With the start of the 2018 budget process, we noted our PALF allotment at \$3,057,432; the final amount to be given to the City came in at \$3,220,385.79; \$162,953.79 more than our earliest projection.

Benefits and pay increases will be budgeted as per any bargaining position, adhering to finance guidelines in accordance with active CBA in subsequent budget years.
