AN ORDINANCE

Amending the 2018 Capital Fund Budget to provide for a supplemental appropriation of Fifty Thousand (\$50,000) Dollars from the Wildlands Conservancy to the City of Allentown to assist with funding an alternate scope of work for the Auburn Cross Trails.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ALLENTOWN:

SECTION ONE: That City Council authorizes an increase to the unappropriated balance of the 2018 Capital Fund in the amount of Fifty Thousand (\$50,000.00) Dollars reflecting receipt of monies from the Wildlands Conservancy to the City of Allentown to assist with an alternate scope of work for Auburn Cross Trails.

SECTION TWO: That City Council authorizes a supplemental appropriation from the unappropriated balance of the Capital Fund as follows:
