#### AN ORDINANCE

Amending the 2018 General Fund Budget to provide for a supplemental appropriation of One Thousand dollars (\$1,000.00) as a result of a donation from the Petco Foundation in support of the State Farm Arson Dog to the Allentown Fire Department for the purchase of Arson Dog Equipment and Supplies.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ALLENTOWN:

SECTION ONE: That City Council authorizes an increase to the unappropriated balance of the 2018 General Fund in the amount of One Thousand (\$1,000.00) Dollars reflecting receipt of monies from the Petco Foundation in support of the State Farm Arson Dog to purchase Arson Dog Equipment and Supplies.

SECTION TWO: That City Council authorizes a supplemental appropriation from the unappropriated balance of the General Fund to the Fire Department budget as follows:
