AN ORDINANCE

Amending the 2018 General Fund Budget and the 2018 Stormwater Fund Budget to provide for transfer of funds for the annual lease payment of equipment used for Stormwater operations as shown in Sections One through Four and the payment of the Stormwater fee for City-owned properties as shown in Section Five.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ALLENTOWN:

SECTION ONE: That City Council authorizes a reduction in the General Fund Expenditures in the amount of Two Hundred Forty-Seven Thousand Nine Hundred Forty-Seven (\$247,947) Dollars for the lease payment of Stormwater equipment in the following account:

**General and Civic**

- **Summary and Facts of the Bill**

This Ordinance transfers funds from General Fund to the Stormwater Fund for the annual lease payment of Stormwater Equipment, removes the expense from the Equipment Fund and appropriates the funds within the General Fund to pay the Stormwater Fund for the Stormwater fee for City-owned properties.

In preparation of the 2018 budget \$247,947 was budgeted in the General Fund for the lease payments on equipment that is used for Stormwater projects. The Stormwater Fund is the correct fund for the expenditure to be paid from.

Also, this Ordinance provides for the payment of the Stormwater Fee for City-owned properties to be paid to the Stormwater Fund in the amount of \$255,620.

Due to expenditures being reduced in the General Fund by \$247,947, the net amount needed from the unappropriated balance to pay the Stormwater Fee for City-owned properties is \$7,673.00.

\* Reduce General Fund Expenditures (000-01-0609-0001-88) by \$247,947, by doing so this amount automatically increases the unappropriated balance of the General Fund.

\* Reduce the revenue and expenditures of the Equipment Fund by \$247,947 each which will remove the funds to pay for the annual lease of the Stormwater equipment (Equipment Fund is funded by the General Fund).

\* Increase the expenditures in the Stormwater Fund by \$247,947 to pay for the lease payment of the equipment from the Stormwater Fund.

\* Increase the General Fund expenditure account 000-01-0609-0001-50 from the unappropriated balance of the General Fund by \$255,620 to pay the Stormwater Fee for City-owned properties. Due to expenditures being reduced in the General Fund by \$247,947, the net amount needed from the unappropriated balance to pay the Stormwater Fee for City-owned properties is \$7,673.00.
