AN ORDINANCE

Amending the 2018 Capital Fund Budget to provide for a supplemental appropriation of One Hundred Thousand (\$100,000) Dollars from UGI to the City of Allentown for the installation of handicap ramps on Walnut Street from 10th Street to 15th Street as part of a cost-sharing project.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ALLENTOWN:

SECTION ONE: That City Council authorizes an increase to the unappropriated balance of the 2018 Capital Fund in the amount of One Hundred Thousand (\$100,000.00) Dollars reflecting from UGI for the installation of handicap ramps on Walnut Street from 10th Street to 15th Street as part of a cost sharing project.

SECTION TWO: That City Council authorizes a supplemental appropriation from the unappropriated balance of the Capital Fund as follows:
