#### AN ORDINANCE

Amending the 2018 General Fund budget by adding a total of three positions in the Bureau of Building Standards and Safety. Two Housing Inspectors (14M, Step D) each budgeted at an annual salary of Fifty Thousand Five Hundred Sixty (\$50,560) Dollars and one Clerk III (8M, Step D) budgeted at an annual salary of Forty-Four Thousand Forty-Five (\$44,045) Dollars.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ALLENTOWN:

SECTION ONE: That pages 251 and 252 be amended by adding one Housing Inspector in the Rental Unit Inspection program (14M, Step D) budgeted at an annual salary of Fifty Thousand Five Hundred Sixty Dollars (\$50,560).

SECTION TWO: That pages 254 and 255 be amended by adding one Housing Inspector in the Presale Program (14M, Step D) budgeted at an annual salary of Fifty Thousand Five Hundred Sixty Dollars (\$50,560) and one Clerk III (8M, Step D) budgeted at an annual salary of Forty-Four Thousand Forty-Five Dollars (\$44,045).

SECTION THREE: That City Council authorizes a transfer within the Bureau of Building Standards and Safety to fund these positions for the remainder of 2018 from current unfilled positions as follows:

# • What Department or bureau is Bill originating from? Where did the initiative for the bill originate?

Community and Economic Development, Bureau of Building Standards and Safety.

### • Summary and Facts of the Bill

The Bureau is diligently working towards meeting the schedule for Systematic Inspections as wells as Complaint Inspections and PreSale Inspections. The number of requested PreSale Inspections has increased dramatically over the past year, while the rental stock is aging and increasing the need to stay on top of rental inspections. Therefore, the Bureau requests to add one additional PreSale Inspector, one additional Rental Inspector and one additional PreSale Clerk III.

By approving this request in a timely manner, we would immediately move forward with filling these positions (start dates within 60 to 90 days), which would allow the staff to clear the current backlog of inspections to be scheduled and complete more systematic inspections.

# • Why should Council unanimously support this bill?

1.) This bill would bolster our inspection statf in order to reduce the PreSale inspection backlog and provide better service to City Residents; 2.) provide additional resources to our Systematic Rental Inspections, which creates safer living conditions for City of Allentown residents; 3.) reduce the overtime expenses, which is currently needed to keep up with the unanticipated inspection

workload the staff is dealing with; 4.) Increase revenue to the department by completing more inspections than were budgeted.
