Authorization for one-year contract with ABE Fence, Inc. to provide emergency services for fencing and guardrail repair - 2 bids, contact can be renewed for 2 additional one year periods.

Resolved by the Council of the City of Allentown, That

WHEREAS, Article 130.16 of the City's Administrative Code requires City Council approval by Resolution for the award of contracts or engagement of professional services.

WHEREAS, it is the desire of the City of Allentown to enter into an agreement/engage the services of the following named contractor/consultant, for the use and purpose indicated in supporting the Recommendation of Award of Bid or Contract dated July 18, 2018:

- 1. Name of Contractor/Consultant: ABE Fence, Inc.
- 2. Project or Contract Reference: 2018-11
- 3. Description of Service(s) to be provided: contractor shall provide emergency as needed fencing and guardrail repair services. The awarded vendor will provide routine fencing and/or guardrail repairs at various location throughout the City of Allentown on an as needed basis at a flat rate per hour and at a maximum defined mark-up for parts and materials throughout the duration of the contract period. The awarded vendor must be in the business of repairing and installing either fencing or guardrail and will have adequate manpower to satisfy the City of Allentown's routine requirements.

NOW, THEREFORE, BE IT RESOLVED that the Council of the City of Allentown, hereby authorizes the Mayor and/or such other City officials as deemed appropriate by the City Solicitor, to sign and execute a Contract or Amendment and such other agreements and documents as are deemed by the City Solicitor to be necessary and/or related thereto, with the above named contractor/consultant, for the project identified.

The intent of this bid to secure contractors to provide emergency as needed fencing and guardrail repair services. The awarded vendor will provide routine fencing and/or guardrail repairs at various location throughout the City of Allentown on an as needed basis at a flat rate per hour and at a maximum defined mark-up for parts and materials throughout the duration of the contract period. The awarded vendor must be in the business of repairing and installing either fencing or guardrail and will have adequate manpower to satisfy the City of Allentown's routine requirements.
