Amending the 2018 Equipment Fund Budget and the 2018 General Fund Budget to provide for a transfer between funds in the amount of Two Hundred Twenty Thousand (\$220,000) Dollars for changes to the existing Microsoft Enterprise Agreement as it relates to the Malware situation.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ALLENTOWN:

SECTION ONE: That City Council authorizes a supplemental appropriation from the unappropriated balance of the 2018 Equipment Fund in the amount of Two Hundred Twenty Thousand (\$220,000.00) Dollars for changes to the existing Microsoft Enterprise Agreement as it relates to the Malware situation as follows:

Summary and Facts of the Bill

The City of Allentown was compromised by a credential theft attack in February 2018 infecting the entire Microsoft infrastructure. MS Consulting is on premise re-architecting & rebuilding our entire MS infrastructure. The City needs to change its licensing model to ensure a secure environment for the future and is requesting changes to our licensing model for the last year of the current agreement or would like a new three year agreement.
