Amending the 2018 General Fund and the 2018 Capital Fund Budget to provide for a supplemental appropriation of Six Hundred Sixty-Six (\$666.00) Dollars. This was a result of payment for tree damage caused by an auto accident on Hanover Avenue in 2016.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ALLENTOWN:

SECTION ONE: That City Council authorizes a supplemental appropriation from the unappropriated balance of the General Fund as follows:

SECTION TWO: That City Council authorizes an increase to the unappropriated balance of the 2018 Capital Fund in the amount of Six Hundred Sixty-Six (\$666.00) Dollars reflecting receipt of monies for tree damage caused by an auto accident.

SECTION THREE: That City Council authorizes a supplemental appropriation from the unappropriated balance of the Capital Fund as follows:

#### Shade Tree Revitalization

SECTION FOUR: That this Ordinance will take effect ten (10) days after final passage.
