AN ORDINANCE

Amending the 2018 General Fund Budget to provide for a supplemental appropriation of Ten Thousand Six Hundred Sixty (\$10,660) Dollars from the Women's 5K Classic to the City of Allentown to promote breast and cervical cancer screening in the Lehigh Valley.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ALLENTOWN:

SECTION ONE: That City Council authorizes an increase to the unappropriated balance of the 2018 General Fund in the amount of Ten Thousand Six Hundred Sixty (\$10,660.00) Dollars reflecting receipt of monies from the Women's 5K Classic to the City of Allentown to promote breast and cervical cancer screening in the Lehigh Valley

SECTION TWO: That City Council authorizes a supplemental appropriation from the unappropriated balance of the General Fund as follows:

The bill originated from the Department of Community Development, Bureau of Health. An award of \$10,660 in new funds are being provided by the Women's 5K Classic to promote breast and cervical cancer screening in the Lehigh Valley.

• Summary and Facts of the Bill

Amending the 2018 General Fund Budget to provide for a new appropriation of Ten Thousand Six Hundred Sixty Dollars (\$10,660) from the Women's 5K Classic.

The purpose of the funding is to maintain and expand breast and cervical cancer education and awareness initiatives, promote the importance of screening for the early detection of breast and cervical cancers, and provide information about available breast and cervical cancer resources for citizens who have limited or no health insurance.

A benefit of this Bill is that through education, outreach and marketing activities there will be increased focus on the importance of screening exams for the early detection of breast and cervical cancers. Breast and cervical cancers are leading public health issues faced by women in our community and their families. By collaborating with local hospitals and public health agencies, there will be a coordinated effort to conduct education, outreach and marketing activities.

This Bill is congruent with the Health Bureau's mission to prevent disease and injury and to protect and promote the public's health.

Passing this Bill will not result in a financial cost to the City. \$10,660 in new expenditures will be placed in the 2018 budget.
