## AN ORDINANCE

Amending the 2018 General Fund Budget for a supplemental appropriation of Two Thousand Five Hundred Twenty-Five Dollars and Eighty-Five Cents (\$2,525.85) as a result of a disbursement from the Pennsylvania Emergency Medical Services Council from the State EMS Operating Fund (EMSOF) for medical equipment.

#### BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ALLENTOWN:

SECTION ONE: That City Council authorizes an increase to the unappropriated balance of the General Fund in the amount of Two Thousand Five Hundred Twenty-Five Dollars and Eighty-Five Cents (\$2,525.85) as a result of a disbursement from the PA EMS Council from the State EMS Operating Fund (EMSOF).

SECTION TWO: That City Council authorizes a supplemental appropriation from the unappropriated balance of the General Fund in the amount of Two Thousand Five Hundred Twenty-Five Dollars and Eighty-Five Cents (\$2,525.85) in the following manner:

Emergency Medical Services

## • Summary and Facts of the Bill

Allows for the appropriation of a \$2,525.85 paid to EMS by the Eastern PA EMS Council as the 2018 disbursement of State EMS Operating Fund (EMSOF). The monies would be placed in the EMS equipment account, 000-05-0605-0003-72 to help purchase additional medical equipment. They currently reside in revenue account 000-5240 (Grants and other programs).

This state administered program is funded from a surcharge on moving traffic violations issued by police agencies in the Pennsylvania. The funds are distributed to the 16 regional EMS councils and then on to local groups and organizations. The money can be used for numerous projects. There is no downside or "strings" attached to this money. Allentown EMS qualifies by complying with all state reporting guidelines.
