AN ORDINANCE

Amending the 2018 General Fund budget to accommodate position changes in the Department of Finance, Bureau of Accounting and Financial Management, eliminating the position of Deputy Finance Director and Treasury and reinstate the Treasury and Accounting Manager position.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ALLENTOWN:

SECTION ONE: That page 59 of the General Fund budget be amended by deleting the position of Deputy Finance Director and Treasury (18N) at an annual salary of Ninety-Three Thousand Two Hundred Eighty-Eight (\$93,288) and reinstate the position of Treasury and Accounting Manager (17N) at an annual salary of Eighty-Five Thousand (\$85,000) Dollars.

SECTION TWO: That the net savings of Thirteen Thousand Three Hundred Sixteen (\$13,316) Dollars will be added to the unappropriated balance of the General Fund.

SECTION THREE: That this Ordinance will take effect ten (10) days after final passage.

SECTION FOUR: That all Ordinances inconsistent with the above provisions are repealed to the extent of their inconsistency.
