AN ORDINANCE

Amending the 2018 General Fund Budget to provide for a supplemental appropriation of Four Thousand Twenty-Five (\$4,025) Dollars from the Commonwealth of Pennsylvania, Office of the Attorney General to the City of Allentown to be used to purchase one set of antennae and ten individually programmed radio transmitters bracelets for Project LifeSaver Clients.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ALLENTOWN:

SECTION ONE: That City Council authorizes an increase to the unappropriated balance of the 2018 General Fund in the amount of Four Thousand Twenty-Five (\$4,025) Dollars reflecting receipt of monies from the Commonwealth of Pennsylvania, Office of the Attorney General for Project Life Saver.

SECTION TWO: That City Council authorizes a supplemental appropriation from the unappropriated balance of the General Fund as follows:

SECTION THREE: That this Ordinance will take effect ten (10) days after final passage.
