AN ORDINANCE

Amending the 2018 Capital Fund Budget by transferring Two Thousand Eight Hundred Thirty-Seven Dollars and Eighty-One Cents (\$2,837.81) from completed Capital Projects including Keck Park Improvements, Jackson Street Community Park Development, WPA Structures and Jordan Park Playground to Capital Project 1905 City-wide Parks and Playgrounds for the repair to the wall in Trexler Park.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ALLENTOWN:

SECTION ONE: That City Council authorizes a transfer within the Capital Fund in the amount of Two Thousand Eight Hundred Thirty-Seven Dollars and Eighty-One Cents (\$2,837.81) as follows:

Move \$2,837.81 of Trexler funds from completed capital projects into Citywide Parks and Playgrounds so funds may be used to repair the wall in Trexler Park.

Move Trexler funds from completed projects to Citywide Parks and Playgrounds capital account to fund repairs for the Trexler Park wall.

Move \$25.43 001-08-2204-1460-72 (Jordan Park Playground) to 001-08-1905-1460-46 (Citywide Parks and Playgrounds)
