HISTORY OF THE PORTION OF THE STREET PROPOSED TO BE VACATED:

The portion of East Hedge street proposed to be vacated is in the 15th Ward. The Plan of Oakside #3, Property of Kaeppel & Kester, Dated May 1923 and recorded in the Office of the Lehigh County Recorder of Deeds in Map Book2 Page 146 established the northern 16.5' of the R/W. The Southern Portion of the R/W was established by the Pleasant View Terrace Annex Plan located at that time was located in Hanover Township, dated October, 1919 and recorded in Map Book 2 Page 42 in the Office of the Lehigh County Recorder of Deeds, the road system of this plan was adopted by the Annexation Ordinance Bill No. 1027, dated January 26, 1920. A southern portion was also established by a R/W dedication by Deed Book 1582 Page 979.

LOCATION AND CONDITION:

The subject portion of street to be vacated is currently paved and used as a private parking area. The overall right-of-way has a variable width and an improved 30' wide cart-way. There are existing utility poles within the Street right-of-way.

- 3. The applicant shall incorporate the vacated area into their parcel by the recording of a consolidation deed within 90 Days from the approval of the ordinance.






