AN ORDINANCE

Amending the 2018 Capital Fund Budget to provide for a supplemental appropriation of Eighty Thousand (\$80,000) Dollars from the Pennsylvania Historical and Museum Commission to the City of Allentown toward the preservation of Bogert's Covered Bridge

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ALLENTOWN:

SECTION ONE: That City Council authorizes an increase to the unappropriated balance of the 2018 Capital Fund in the amount of Eighty Thousand (\$80,000) Dollars reflecting receipt of monies from the Pennsylvania Historical and Museum Commission into revenue account:
