AN ORDINANCE

Amending the 2019 Solid Waste Fund Budget for a supplemental appropriation of Eight Hundred Dollars (\$800.00) as a result of a scholarship received from Keep America Beautiful to attend the Keep America Beautiful 2019 National Conference.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ALLENTOWN:

SECTION ONE: That City Council authorizes an increase to the unappropriated balance of the Solid Waste Fund in the amount of Eight Hundred Dollars (\$800.00) for expenses incurred to attend the Keep America Beautiful 2019 National Conference.

Solid Waste Fund Revenue

SECTION TWO: That City Council authorizes a supplemental appropriation from the unappropriated balance of the Solid Waste Fund in the amount of Eight Hundred Dollars (\$800.00) in the following manner:

Solid Waste Fund Recycling and Solid Waste Collection/Disposal/Recycling

SECTION THREE: That this Ordinance will take effect ten (10) days after final passage.

SECTION FOUR: That all Ordinances inconsistent with the above provisions are repealed to the extent of their inconsistency.
