\$15,000 for the initial contract term.

Upon mutual written agreement by both parties the contract term maybe extended for up to three (3) additional one (1) year terms.

 Maximum dollar value of all renewals provided for beyond the original term as if all renewals were exercised:

Each renewal year shall be at a sum of \$15,000 which totals \$45,000 for all three renewals.

Administration of Enterprise Zone Loan Fund, for manufacturing companies in Allentown, which is inclusive but not limited to, underwriting servicing and loan closings.

Enterprise Zone is a state designated program and AEDC has been the administrator of the Enterprise Zone.
