AN ORDINANCE

Amending the 2019 Grant Fund Budget to provide for a supplemental appropriation of One Hundred Forty-Six Thousand Seven Hundred Eighty-Four (\$146,784.00) Dollars from the Pennsylvania Commission on Crime and Delinquency as a pass-through grant to fund the Allentown Cure Violence program being implemented by Promise Neighborhoods of the Lehigh Valley.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ALLENTOWN:

SECTION ONE: That City Council authorizes an increase to the unappropriated balance of the 2019 Grant Fund in the amount of One Hundred Forty-Six Thousand Seven Hundred Eighty-Four (\$146,784.00) Dollars reflecting receipt of monies from the Pennsylvania Commission on Crime and Delinquency into revenue account:

- **Summary and Facts of the Bill**

Purpose of the ordinance is to appropriate the revenue and expenses for the Gun Violence Reduction Initiative grant that will fund the pilot of Cure Violence. The \$146,784.00 grant is funded through the Pennsylvania Commission on Crime and Delinquency (PCCD).

The project will provide funding for the pilot of Allentown Cure Violence being implemented by Promise Neighborhoods of the Lehigh Valley, the subgrantee. The project includes an Assessment Visit by the National Cure Violence organization, as well as provides for staff salaries/benefits, ongoing training and consultation, supplies, and program administration.

The project is designed to identify potential gun-related violence before it occurs and intervene both prior to and after gun-related violence incidents in a targeted neighborhood within the City.

The total project budget for the 1-year grant/project term is \$146,784.00. There is no match requirement. Promise Neighborhoods of the LV is implementing the project and incurring all expenses.
