## AN ORDINANCE

Amending the 2019 General Fund Budget to provide for a supplemental appropriation of Fifty-Five Thousand Seven Hundred (\$55,700.00) Dollars from the United States Department of Justice to the City of Allentown for the purchase of Fifty-Five (55) ballistic tactical helmets, four (4) portable radar speed signs as well as Twelve Thousand (\$12,000) to the County of Lehigh toward the purchase of their drone camera and computer software equipment.

SECTION ONE: That City Council authorizes an increase to the unappropriated balance of the 2019 General Fund in the amount of Fifty-Five Thousand Seven Hundred (\$55,700.00) Dollars reflecting receipt of monies from the United States Department of Justice Grant into revenue account:

## Summary and Facts of the Bill

Purpose of the ordinance is to appropriate the revenue and expenses for the 2018 JAG grant that will fund the purchase of portable speed radar signs as well as ballistic helmets for the department.
