Ms. Jessica Baraket stated that this was done as Bid 2019-02. It was advertised on Public Purchase and accessed by 25 vendors. We received two bid responses and one no bid response with Buckman offering the

greatest revenue back to the city.

Mr. Roger MacLean asked if the city used them before.

Ms. Jessica Baraket stated that the city did not use them before.

Mr. Roger MacLean asked if there were any questions from his colleagues.

Mr. Daryl Hendricks asked if we take the materials to them.

Ms. Jessica Baraket stated yes.

Mr. Courtney Robinson stated that of the other two bids, there was nothing in the bid documents that was returned. This firm is in Coplay and the other firm was in Allentown. Was there a benefit analysis done?

Ms. Jessica Baraket stated that they submitted a no bid response.

Mr. Craig Messinger stated that they took in account the little bit longer travel time for equipment and employee costs. They analyzed that over all the materials over the last three years we would have recycled. The revenue outpaced the little extra time and other cost. That is also figuring the five person cost benefit. It was still \$30,000 more.

Mr. Julio Guridy asked how much revenue we generate on a regular basis. He asked if they re-advertise it every three years.

Mr. Craig Messinger stated that we had Mascaro actually pick the material up and take it. Now we have a Maintenance Worker III. It is about \$33,500 a year that we would generate from it. He stated that it is market driven. He stated that there are one year extensions.

Ms. Jessica Baraket stated that it is for the three year term and can be extended for an additional three one year option.

Mr. Julio Guridy stated that it would be wise to re-advertise it to see if anybody else gives us a better price.

Mr. Craig Messinger stated that is what he is saying. If the market is low, you are not going to get a better price. If the market is high and they are looking for the material, we will not extend it.

Mr. Joseph McMahon stated that if the market goes lower than the contract that we have, why would we go out to bid to lower the price.

One proposal was received and the proposal was evaluated by a committee of five voting members and one non-voting member. The committee conducted both technical and cost evaluations and determined that they are recommending awards Rapid Response.

Mr. Courtney Robinson stated that in the supporting documentation it says it is for moving chemicals from city owned properties, streets, sewers and waterways, and city facilities on an as needed emergency basis and private property. He stated that he wants to confirm that this is who the city uses for any hazmat issues after the hazmat team comes out.

Ms. Jessica Baraket stated that is what this is for.
