AN ORDINANCE

Amending the 2019 Capital Fund Budget to provide for a supplemental appropriation of Three Hundred Thousand (\$300,000) Dollars from the Commonwealth of Pennsylvania Bureau of Environmental Protection to the City of Allentown for reimbursement of Watershed Restoration and Protection Program work on the Livingston Watershed.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ALLENTOWN:

SECTION ONE: That City Council authorizes an increase to the unappropriated balance of the 2019 Capital Fund in the amount of Three Hundred Thousand (\$300,000) Dollars reflecting receipt of monies from the Commonwealth of Pennsylvania Bureau of Environmental Protection:

SECTION TWO: That City Council authorizes a supplemental appropriation from the unappropriated balance of the Capital Fund as follows:
