AN ORDINANCE

Amending the 2019 Capital Fund Budget to provide for a supplemental appropriation of Thirty-Five Thousand Dollars (\$35,000.00) from Pennsylvania Department of Conservation and Natural Resources (DCNR) toward developing a master site plan for Lehigh Canal and Franklin Parks.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ALLENTOWN:

SECTION ONE: That City Council authorizes an increase to the unappropriated balance of the 2019 Capital Fund in the amount of Thirty-Five Thousand Dollars (\$35,000.00) reflecting receipt of monies from PA DCNR toward developing a master site plan for Lehigh Canal and Franklin Parks.
