AN ORDINANCE

Amending the 2019 Capital Fund Budget to provide for a supplemental appropriation of Fifty Thousand (\$50,000) Dollars as the result of a grant from the Pennsylvania Department of Conservation and Natural Resources for the for payment of professional services to design, complete construction documents, provide bid assistance and build a portion of the Allentown section of the Jordan Creek Greenway Trail that will ultimately run from Turner St. to Jordan Park and MacArthur Rd.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ALLENTOWN:

SECTION ONE: That City Council authorizes an increase to the unappropriated balance of the 2019 Capital Fund in the amount of Fifty Thousand (\$50,000) Dollars reflecting receipt of monies from the Pennsylvania Department of Conservation and Natural Resources for the design phase of the Jordan Creek Greenway Trail.

SECTION TWO: That City Council authorizes a supplemental appropriation from the unappropriated balance of the Capital Fund as follows:

Jordan Creek Greenway Trail

SECTION FOUR: That all Ordinances inconsistent with the above provisions are repealed to the extent of their inconsistency.

Summary and Facts of the Bill

In 2017 City Council passed Ordinance 15371 which appropriated \$150,000 from DCNR for a grant toward the design and construction of Jordan Creek Greenway. At that time the award letter was incorrectly interpreted. The City was awarded a total of \$200,000. This ordinance appropriates the additional \$50,000 that was not included in 2017.
