No. <u>28</u> RESOLUTION R - 2019

Introduced by the Administration on April 3, 2019

Authorizes Submission of an Application to the Pennsylvania Department of Conservation and Natural Resources for a Grant of Two Hundred Fifty Thousand Dollars (\$250,000) for the construction and development of Valania Park.

Resolved by the Council of the City of Allentown, That

BE IT RESOLVED, that the City of Allentown, Lehigh County hereby requests a Community Conservation Partnerships Program Grant of \$250,000 from the Pennsylvania Department of Conservation and Natural Resources to partially defray the costs of the Valania Park redevelopment project.

BE IT FURTHER RESOLVED, that the City of Allentown hereby designates Ray O'Connell, Mayor, and Brent Hartzell, Finance Director, as the official(s) to execute all documents and agreements between the City of Allentown and the Commonwealth Financing Authority to facilitate and assist in obtaining the requested grant.

NOW, THEREFORE, BE IT RESOLVED that the Council of the City of Allentown, hereby authorizes the City of Allentown to submit the application for Two Hundred Fifty Thousand Dollars (\$250,000) in Community Conservation Partnerships Program funds to the Department of Conservation and Natural Resources.

Summary and Facts of the Bill

The City is submitting an application to the Department of Conservation and Natural Resources for a \$250,000 grant to support renovations to Valania Park. These funds, which must be matched dollar for dollar, will supplement available CDBG funding to complete Phase I renovations to Valania Park. RFP for construction documents, design, and engineering is currently underway.

The resolution will allow the City to make application for these funds and help defray necessary costs for the Parks Department, while also leveraging CDBG funds. The Valania Park renovation is a high-priority project.
