The project involves the improvement of Fifteen (15) intersections traffic signal improvements along Lehigh Street with video detection and tie in with City's existing traffic signal adaptive system via radio and fiber optic communication system. This contract included the preliminary and final design, prepare traffic signal construction plans and PennDOT coordination.

Reasons for recommendation of Administration and Council approval of contract:

The City received Green Light Go (GLG) PennDOT grant for the Lehigh Street Corridor System Management and Mobility (LSCSMM) project for the amount of \$774,378.00.00. The City will provide a local match in the amount of \$193,594.00 for a total project amount of \$967,972.00. The project involves the improvement of Fifteen (15) intersections traffic signal improvements along Lehigh Street with video detection and tie in with City's existing traffic signal adaptive system via radio and fiber optic communication system. This contract included the preliminary and final design, prepare traffic signal construction plans and bid documents and PENNDOT coordination.

The City obtained the approval from PENNDOT to use the same engineering firm which, the City selected through the federal and state selection guidelines and approval process for the "Municipal Traffic Engineer" for the downtown traffic signal phase IA project design services.
