AN ORDINANCE

Amending the 2019 General Fund Budget to provide for a supplemental appropriation of Forty-Seven Thousand Six Hundred Seventy-Nine Dollars and Ninety Cents (\$47,679.90) from the Municipal Police Officers' Education and Training Commission (MPOETC) to be used at the Allentown Police Academy for training and operating expenses related to Act 120 classes.
