Mr. Lou Hershman, 405 N. Gilmore Street, asked about budget time and the Solid Waste Fund and the Memorandum of Understanding available to the public to repay the loan to the Solid Waste Fund. He asked about the Golf Course Fund and the season passes. The city is in the hole at the Golf Fund for \$600,000. He talked about the Parking Authority and the two Council members being on the board.

Mr. Roger MacLean stated that Mr. Hartzell said it will be done by the end of June.

Mr. Brent Hartzell stated that's what he anticipates. Next week the proceeds will be distributed to the Refunding Loan. He was waiting for the proceeds to come in before making the payments.

Mr. Courtney Robinson stated that we have two members, but city law requires that we have one.

Mr. Jeff Glazier stated that the administration and the Parking Authority are working on a new contract that will address the deficiencies and the agreement will be brought to Council. It is a revenue contract.

Mr. Brent Hartzell stated whatever needs to be done to bring it forward, of course. It is to align where there are legitimate cost. He will follow up with the Parking Authority.

Mr. James Whitney, 924 Walnut Street, talked about the Pennsylvania Sunshine Act. The Sunshine Act says that the public has the right to comment on issues that are or may be before the board.

Mr. Roger MacLean stated that Mr. Whitney referred to an item on the agenda.

Mayor Ray O'Connell stated that a lot is going on this weekend. Tonight on-street parking at the vicinity of PPL Center on non event nights which is tonight is free after 5:00 PM beginning this evening. Enforcement of meter parking on Hamilton, Linden and Walnut Streets between 4th and 12th Streets and the unit blocks of Linden and Walnut Streets ends at 5:00 PM instead of 6:00 PM. They removed 80 yards at the Rose Garden. They put down 80 yards of soil because of the infection of the roses and planted 750 rose bushes. As Mr. Messinger said early, the 2019 street paving program is in full swing from now until the end of October at a total cost of \$1.3 million. Mr. Roger MacLean asked if there were any comments from my colleagues or the public.

Mr. James Whitney, 924 Walnut Street, that the earlier in the meeting he talked about the Sunshine Act and accidentally referred to this Resolution. We now have the opportunity to talk about this Resolution. This Resolution would take away the ability for the public to comment on full City Council on regarding Bills and Resolutions you are introducing before final passage. He stated that Council wanted to give it a try and never changed it. It is going to the committee.

Mr. Julio Guridy stated that this is the way that it has been for many, many years. Five years ago, we made an effort to change the Administrative Code.

Mr. James Whitney asked if all members of Council part of the committee. He stated that if this passes the only opportunity to speak to the entire Council at once regarding a particular legislation will be on final passage.

Mr. Julio Guridy stated that all members can come if they have an interest in a Bill or Resolution that is being discussed.

Mr. Daryl Hendricks stated that it is important to note that those members who may be able to speak from the administration will not be present, as they are not here every evening. He stated that he does not want to answer questions without the experts here to offer their input.

Mr. Ed Zucal asked Ms. Fruhwirth to weigh in on that on if it is a violation or not.

Ms. Fran Fruhwirth stated that the Solicitor's office will be happy to look into it.

Mr. Edward John White, 1922 W. Highland Street, stated that he would like

to see an actual copy of the proposed ordinance or change. If a proposed ordinance is introduced that means it is on the Agenda as a agenda item and subject to comment on if it is being referred to committee or not. He asked is that correct. You wait until the agenda item comes up and you get to discuss it and the public can make a comment. He stated that he doesn't see an issue with the Sunshine Law. He sees an issue of whether you can comment as a citizen of Allentown.

Mr. Daryl Hendricks stated that you don't vote on it at introduction. It goes to committee.

Mr. Courtney Robinson stated that if the rule changes, then the opportunity that you and Mr. Whitney will only be able to exercising right now will only be able to be exercised at the committee meeting and Council meeting for final vote.

Mr. Edward White stated that is a mistake.

Mr. Courtney Robinson stated that he would agree.

Mr. Julio Guridy stated that those are Council Rules. We make our own rules. We can change our rules anytime.

Mr. Edward White asked for a copy of the proposed ordinance change.

Mr. Roger MacLean asked if there were any other questions on R36.
