AN ORDINANCE

Amending the 2019 Capital Fund Budget by transferring from One Hundred Thousand (\$100,000) Dollars from Capital Project 2026 – MLK Drive and Lehigh Street to Capital Project 2023 – Pedestrian Safety and Signal Improvement to allow for the City Match funds and the Federal Grant funds to be together in one Capital Project.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ALLENTOWN:

SECTION ONE: That City Council authorizes a transfer within the 2019 Capital Fund in the amount of One Hundred Thousand (\$100,000) Dollars as follows:

Summary and Facts of the Bill

In 2018 the City received the Transportation Alternatives Set-Aside (TASA) Fund grant in the amount of \$297,274 for the Lehigh Street (S.R 0145) and Martin Luther King, Jr. Drive Traffic Signal improvement project and Capital Project 2023 was created. As part of the grant requirement the City needed to provide a \$100,000 match. This match was provided through the 2018 short-term bond was placed in Capital Project 2026 not realizing it should have been appropriated into Capital Project 2023. This Bill combines the City match funds in Project 2026 with the grant funds in Project 2023.

Therefore, a transfer moving \$297,274 from Account 46 to 76 is also included in the Bill.
