SUBJECT: 2020 Minimum Municipal Obligation for the Police Pension Plan

Act 205 of 1984 requires that the "Chief Administrative Officer" of the pension plan inform the "governing board" of the municipality of the Minimum Municipal Obligation (MMO) for the following year by the last day in September. This memo is intended to satisfy this legal requirement.

The calculation of the 2020 Minimum Municipal Obligation requires several assumptions relating to projected payroll. The attached 2020 Minimum Municipal Obligation certification details this determination.

Please understand that the MMO is the City's 2020 bill for this pension plan. The calculated obligation must be paid by December 31, 2020. The obligation must be met with general fund monies or with any General State Aid to Municipal Pensions to which we may be entitled under Act 205.
