AN ORDINANCE

Amending the 2019 General Fund Budget to provide for a supplemental appropriation of Forty-Eight Thousand Seven Hundred Nine Dollars and Sixty-Five Cents (\$48,709.65) from the Municipal Police Officers' Education and Training Commission (MPOETC) to be used at the Allentown Police Academy for training and operating expenses related to Act 120 classes.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ALLENTOWN:

SECTION ONE: That City Council authorizes an increase to the unappropriated balance of the 2019 General Fund in the amount of Forty-Eight Thousand Seven Hundred Nine Dollars and Sixty-Five Cents (\$48,709.65) from the Municipal Police Officers' Education and Training Commission (MPOETC).

SECTION TWO: That City Council authorizes a supplemental appropriation from the unappropriated balance of the General Fund as follows:
