AN ORDINANCE

Amending the 2019 Trexler Fund Budget to provide for a supplemental appropriation of One Hundred Thirty-Seven Thousand Seven Hundred Fifty (\$137,750) Dollars from the Trexler Trust as the balance of the 2019 contribution per General Trexler's will.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ALLENTOWN:

SECTION ONE: That City Council authorizes an increase to the unappropriated balance of the Trexler Fund in the amount of One Hundred Thirty-Seven Thousand Seven Hundred Fifty (\$137,750) Dollars reflecting receipt of funds from the Trexler Trust for their annual contribution:

SECTION TWO: That City Council authorizes a supplemental appropriation from the unappropriated balance of the Trexler Fund in the amount of One Hundred Thirty-Seven Thousand Seven Hundred Fifty (\$137,750) Dollars as follows:

Appropriate \$10,000 to 006-08-6761-0001-68 (Operating Materials and Supplies) for supplies needed for general park improvements.

Appropriate \$51,100 to 006-08-6761-0001-72 (Equipment) for chemical storage building, Bobcate angle broom, Ventrac drop spreader, crane for Ford F-550 (assist with in the ground trash cans), service body (Playground Truck) and Billy Goat Aerator.
