AN ORDINANCE

Amending the 2019 Capital Projects Fund to provide for a supplemental appropriation of One Hundred Ninety-Three Thousand Seven Hundred Seventy-Five Dollars (\$193,775) as a result of the annual receipt of capital improvement funds from the Trexler Trust as designated by Court Order.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ALLENTOWN:

SECTION ONE: That City Council authorizes an increase to the unappropriated balance of the Capital Fund in the amount of One Hundred Ninety-Three Thousand Seven Hundred Seventy-Five Dollars (\$193,775).

Appropriate \$60,000 from 006-08-6761-0001-84 to 001-08-1647-1960-46 for repairs to the West Park Bandshell.

Appropriate \$48,775 from 006-08-6761-0001-84 to 001-08-2206-1960-46 to assist with easements for the Jordan Creek Greenway Trail.

Appropriate \$10,000 from 006-08-6761-0001-84 to 001-08-2213-1960-46 to assist with some of costs for the Valania Park Renovations.

- **Why should Council unanimously support this bill?**

The City and the Trexler Trust agreed for 2019 that 10% of the total Trust contribution to the City be used for capital projects for 2019. Appropriating these funds completes the City's obligation made in that agreement. These funds will be used to help complete several important projects that will improve the City's park system.
