## Introduced by the Administration on October 2, 2019

Approval of Transfers: \$12,700 in Streets to purchase storm grates; \$6,000 in Police to upgrade audio system; \$20,000 in Building Maintenance for overtime; \$20,864.70 in Streets for an environmental consultant to deal with issues relating to a storage tank removal at streets facility.

## Resolved by the Council of the City of Allentown, That

WHEREAS, the Administration has requested Council approve the following transfers:

- Transfer \$12,700 from Account 086-03-0815-0001-54 (Repairs and Maintenance Supplies) to 086-03-0815-0001-42 (Repair and Maintenance) in Streets to purchase storm grates for two locations: Mack Blvd between Vine Street and Dixon Street, and Emaus Avenue and Lancaster Ave.
- Transfer \$6,000 from Account 000-04-0802-0004-90 (Refunds) to 000-04-0802-0004-72 (Equipment) in Public Safety/Police to Upgrade the Current Police Academy classroom audio visual equipment. This is needed for both the Act 120 Classroom plus the larger classroom which is used for training (which is utilized by outside agencies). This equipment has not been upgraded since 2012 and is continually breaking down. It is not cost effective to keep the current equipment.
- Transfer \$20,000 from Account 000-03-0707-0001-04 (Temporary Wages) to 000-03-0707-0001-06 (Premium Pay) in Building Maintenance for Funds are needed to Cover Overtime Expenses for Several Uncompleted Projects.
- Transfer \$20,864.70 from Account 001-03-2007-1501-76 (Construction Contracts) to 001-03-2007-1501-46 (Contract/Services Fees) in Public Works Engineering for Pollutants that were discovered upon removal of the existing underground storage tanks at the street facility. A fund transfer from the 76 construction account to a 46 Professional Services Account is required to hire an environmental consultant to address a PaDEP requirement to prepare a site characterization report.

NOW, THEREFORE, BE IT RESOLVED that City Council hereby approves the transfers.
