AN ORDINANCE

Amending the 2019 General Fund budget by eliminating the position of Building Inspector Assistant Supervisor (12N) at an annual salary of \$68,068 (Sixty-Eight Thousand Sixty-Eight) Dollars and creating an Historical Preservation Planning Officer (13N) at an annual salary of \$68,120 (Sixty-Eight Thousand One Hundred Twenty) Dollars to govern the City's Historic Preservation Ordinance.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ALLENTOWN;

SECTION ONE: That page 220, 228 and 236 of the General Fund budget be amended by eliminating the position of Building Inspector Assistant Supervisor (12N) at an annual salary of \$68,068 (Sixty-Eight Thousand Sixty-Eight) Dollars and creating an Historical Preservation Planning Officer (13N) at an annual salary of \$68,120 (Sixty-Eight Thousand One Hundred Twenty) Dollars to govern the City's Historic Preservation Ordinance

The bill is to reorganize. Move the Assistant supervisor position # 198-001 to the Planning department in order to separate the historical preservation officer from the Chief Planner position to establish a stand alone Historical Preservation Officer for the city.

• Why should Council unanimously support this bill?

The fundamental reason for this position is to develop and direct the programs of the Historic Preservation, and to coordinate City historic preservation programs. The Historic Preservation Officer is responsible for enforcing the historic preservation ordinance, and for providing staff assistance in the implementation of the policies, goals, and programs of the Historic Preservation for the city. There are currently over 200 hundred and counting violation that need attention, hundred more that have not been looked into, plus daily environmental reviews and complaince issues to address. The current HPO is serving as the Chief Planner and this concept is not working nor has it worked effectively in the past. To meet the needs of better governance over this program it requires two full time people.
