Introduced by the Administration on November 13, 2019

Authorizes Submission of an Application to the Pennsylvania Department of Transportation Multimodal Transportation Fund for a Grant of TWO MILLION FIFTY THOUSAND DOLLARS (\$2,050,000) for the LED Street Light Retrofit and Upgrade project.

Resolved by the Council of the City of Allentown, That

BE IT RESOLVED, that the City of Allentown, Lehigh County hereby requests a Multimodal Transportation Fund Grant of \$2,050,000 from the Pennsylvania Department of Transportation to fund LED street light conversion, retrofits, and upgrades within the western and southern portions of the City.

BE IT FURTHER RESOLVED, that the City of Allentown hereby designates Ray O'Connell, Mayor, and Brent Hartzell, Finance Director, as the official(s) to execute all documents and agreements between the City of Allentown and the Commonwealth Financing Authority to facilitate and assist in obtaining the requested grant.

NOW, THEREFORE, BE IT RESOLVED that the Council of the City of Allentown, hereby authorizes the City of Allentown to submit the application for One Million Six Hundred Thousand Dollars (\$2,050,000) in Multimodal Transportation Funds to the Department of Transportation.

The resolution will allow the City to make application for these funds that would assist the Public Works department to complete this project that improves night time visibility, reduces urban sky glow, and reduces City energy usage by 20-30%.
