
## **OFFICE OF COMPLIANCE**


- Manage the Regional Flow Management Strategy projects ensuring compliance with the EPA Aos
- Continue work with the Water & Sewer Compliance Review Board
- Maintain stewardship of Capital Programing
- Complete the Automatic Meter Reading project which is the last "Uncompleted Works" project as defined by the Concession Lease Agreement
- Work with IT to make watershed and PaDEP notifications available on-line
- Continue to assess LCA's compliance with City Ordinances, the Concession Agreement, and Operating Standards




## ENGINEERING

- Construct infiltration Water quality storm water basin at 6th & Sumner
- Construct Gordon Street streetscaping/ lighting 5<sup>th</sup>-7<sup>th</sup>
- Construct American Parkway lighting from Union Street to Airport Road
- Design lighting and streetscaping along Hamilton Street from 5<sup>th</sup> to Church Street
- Coordinate with Penn Dot on the construction on the Gordon Street Bridge
- Continue to perform multiple subdivision and land development reviews for ongoing Citywide developments







## BUILDING MAINTENANCE

- LED lighting upgrades in City owned buildings
- Key Inventory Software implementation
- Improve the effectiveness of preventative maintenance through scheduling in Lucity
- Renovating the Health Bureau Clinic
- Reline the make-up tank for City Hall HVAC system





## STREETS, LIQUID FUELS & FLEET MAINTENANCE

- Continue to work with utility companies on cost sharing projects to improve infrastructure and the repaving of roads
- Repaying of Martin Luther King from S 10<sup>th</sup> Street to Union Street
- Annual completion of mandated MS-965 reporting on our Liquid Fuels actual use
- Will be purchasing a second Jet Vac that will have the capability to hydro-excavate





# TRAFFIC PLANNING & STREET LIGHTING


- Downtown and Lehigh Street Traffic Signal adaptive system project construction will begin in Spring 2020.
- LED conversion, Phase 2 will start summer of 2020.
- American Parkway lighting from Union Street to Airport Road is under design, will start summer 2020
- Construct a new signalized intersection at Lehigh and Union Streets



## TECHNICAL SERVICES

- Work with APD on replacing cameras that have passed their useful life.
- Begin change out of radios purchased in 2009 for public safety.
- Preform PMs on all City Cameras
- Install Emergency Lighting, Siren and Radio equipment in Police, Fire & EMS Fleet
- Continue to change out Fire & EMS MDTs
- Continue assisting EMA with plans Emergency Operations Center

- Manage the City's municipal waste and recycling, collection and disposal contract







## STORMWATER

- Hire new employees to support permit compliance activities, environmental outreach programs and expanded maintenance operations.
- Begin work to address stream impairments
- Partner with non-profits and other private property owners on projects to install green stormwater infrastructure through the utility's Credit and Community Engagement Programs.
- Continue to work with Pennsylvania Department of Environmental Protection to update the terms of the City's MS4 NPDES permit, Stormwater Management Plan, standards of procedure, and ordinances to ensure compliance with the Clean Water Act.
