The services would continue to expand the participation in the USDA's afterschool and summer meal programs to youth. Due to FACES knowledge and expertise, as well as success that occurred in 2019 with increased meals provided to youth through their anti-hunger campaign, we would like to keep the continuity of services in motion. The extension of services would be completed by June 30, 2020.
