### AN ORDINANCE

Amending the 2019 General Fund Budget to provide for a supplemental appropriation of Two-thousand nine-hundred and fifty dollars (\$2,950.00) from FM Global Fire Prevention Grant for the purchase iPads and software for department Fire Marshals.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ALLENTOWN:

SECTION ONE: That City Council authorizes an increase to the unappropriated balance of the 2019 General Fund in the amount of Two-thousand nine-hundred and fifty dollars (\$2,950.00) reflecting receipt of monies from FM Global Fire Prevention Grant to purchase iPads and software for department Fire Marshals.

The bill originated from the Allentown Fire Department

- **Summary and Facts of the Bill**

The Allentown Fire Department was awarded a FM Global Fire Prevention Grant Program to purchase iPads and software for department Fire Marshals to be used in the field.

- **What does the Bill do – what are the specific goals/tasks the bill seek to accomplish**

The Bill will provide funding for the purchase of iPads and software equipment. This funding establishes the funds necessary to procure essential fire service related equipment to enhance operations and assist with Fire Marshals investigations to more efficiently investigate and determine the cause of a fire.

- **What are the Benefits of doing this/Down-side of doing this**

This will provide and offset costs for the purchase of necessary equipment to increase our fire prevention and inspection program. We see no downside to this Bill.

- **How does this Bill related to the City's Vision/Mission/Priorities**

This Bill relates to the City's vision and mission by providing equipment for Fire Prevention education to the city's residents, to ensure all Fire personnel will be properly outfitted and trained to protect and serve the citizens of Allentown and provide a safe City for all who live, work and visit the City of Allentown. It has always been the City of Allentown's priority, as well as every elected official to provide safe and efficient Public Safety services to ensure a safe environment.

Total project is estimated at \$3,949. This benefits the citizens of Allentown as well as all Fire personnel by allowing us to replace old outdated technology with new and improved technology and capabilities.
