AN ORDINANCE

Amending the 2020 General Fund Budget to provide for a supplemental appropriation of Thirty-Nine Thousand Dollars (\$39,000) as a result of a grant from the Centers for Disease Control Foundation to create and expand efforts to combat the opioid epidemic - the grant is for 6 months and will aid in the creation of an opioid death review team to collect data and target programming.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ALLENTOWN:

SECTION ONE: That City Council authorizes an increase to the unappropriated balance of the 2020 General Fund in the amount of Thirty-Nine Thousand Dollars (\$39,000) from the CDC Foundation.

What Department or bureau is Bill originating from? Where did the initiative for the bill originate?

Health - the initiative came from a grant offered to the City of Allentown from the CDC Foundation. The grant dictates the work plan and pilots a tool kit designed to create and enhance efforts to combat the opioid epidemic.

- **Summary and Facts of the Bill**

The grant is a 6 month grant which requires the creation and implementation of a Opioid death review team and the enhancement of existing collaborations between the Health Bureau and local law enforcement both within and outside the city. The grant ultimately would like to see progress in data collection of the facts and demographics around overdose deaths and attempts and then engage community partners to target programming to reduce those numbers.

The Bill allows for the use of a contracted person with extensive experience in death data collection and investigation as well as understanding and partnering with law enforcement to work with Health Bureau staff to analyze data to a census tract level and to coordinate meetings around fatality review, prevention efforts with agencies with like missions including law enforcement and assist in educational outreach. This 6 month grant will provide the lead into a longer grant offered by the PA Department of Health (possibly a three year long grant).

This is a grant funded initiative and will not be a burden on the City's general fund.

This is a 6th month grant which starts 3/1/2020 or upon execution of this Bill and the Subcontractor agreement.

This Bill will allow for data currently collected on a County level to be analyzed specifically to a City level and will create the basis of a task force designed to use that data to target programming to prevent overdoses and overdose deaths for Allentown City residents. It does not pose a burden on the general fund and also supports some staff time currently being paid out of the general fund.
