#### AN ORDINANCE

Amending the 2020 Capital Fund Budget to provide for a supplemental appropriation of One Million Nine Hundred Sixty-Eight Thousand Seven Hundred Seventy-Four (\$1,968,774.00) Dollars from the Allentown Neighborhood Improvement Zone District Authority (ANIZDA) Public Improvement Fund for improvements at Center Square and on Hamilton Street between 5<sup>th</sup> Street and Church Street as well as the South side of 6<sup>th</sup> Street between Hamilton and Type Streets.

#### BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ALLENTOWN:

SECTION ONE: That City Council authorizes an increase to the unappropriated balance of the 2020 Capital Fund in the amount of One Million Nine Hundred Sixty-Eight Thousand Seven Hundred Seventy-Four (\$1,968,774.00) Dollars from the ANIZDA Public Improvement Fund as follows:

### Summary and Facts of the Bill

The purpose of this ordinance is to appropriate funds the City is receiving from the Allentown Neighborhood Improvement Zone District Authority (ANIZDA) Public Improvement Funds in the amount of \$1,968,774 for capital improvements that will be made within the NIZ area.

There are two capital projects that will receive the ANIZDA funding. First is the Monument Square Redesign which will completely rehabilitate the 7<sup>th</sup> and Hamilton intersection to make it more pedestrian and vehicular friendly. Traffic flow will be adjusted, and pedestrian improvements will focus on safety, aesthetic appeal and activation.

The second capital project is Hamilton Streetscape  $-5^{th}$  to Church Streets. The focus of this project is to replace streetscape elements on Hamilton Street between  $5^{th}$  and Church Streets. Also, the south side of  $6^{th}$  Street between Hamilton and Type Street. The project includes new streetlights, street trees, curbing, sidewalks, ADA ramps, trash receptacles, benches, etc.
