AN ORDINANCE

Amending the 2020 General Fund budget by reorganizing the Community Housing Development Program within the Department of Community Development to better align the positions with the State grant requirements.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ALLENTOWN:

SECTION ONE: That page 206, 207, 210 and 211 of the General Fund Budget be amended as follows:

Delete the Community Housing Coordinator at a paygrade 12(N) with an annual salary of Sixty-Two Thousand Eight Hundred Forty-Two (\$62,842) Dollars and create a Community Housing Manager at a paygrade 14 (N) with an annual salary of Sixty-Five Thousand Nine Hundred Eighty-Four (\$65,984) Dollars.

Delete two (2) Rehabilitation Specialist positions at a paygrade 14 (M) with an annual salary of Forty-Five Thousand Four Hundred Twenty-Six (\$45,426) Dollars and create one Project Manager at a paygrade 13(N) with an annual salary of Sixty Thousand (\$60,000) Dollars. Also, create one Marketing and Social Media Manager at a paygrade 10 (N) with an annual salary of Fifty-Six Thousand Eighty-Six (\$56,086) Dollars in the Business Expansion Attraction and Retention Program.

SECTION TWO: That City Council authorizes the transfer of funds needed for the remainder of 2020 as follows:
