No. <u>66</u> RESOLUTION R - 2020

Introduced by the Administration on May 20, 2020

Authorizes Submission of an Application to the Pennsylvania Department of Community & Economic Development for a Grant of One Hundred Forty-Eight Thousand Seven Hundred Fifty Dollars (\$148,750.00) for Use in the development of a Parks and Trails Master Plan.

Resolved by the Council of the City of Allentown, That

BE IT RESOLVED, that the City of Allentown, Lehigh County hereby requests a FY2018 Municipal Assistance Grant of \$148,750.00 from the Pennsylvania Department of Community & Economic Development to support the development of a Parks and Trails Master Plan.

BE IT FURTHER RESOLVED, that the City of Allentown hereby designates the Mayor and Finance Director as the official(s) to execute all documents and agreements between the City of Allentown and the Department of Community & Economic Development to facilitate and assist in obtaining the requested grant.

NOW, THEREFORE, BE IT RESOLVED that the Council of the City of Allentown, hereby authorizes the City of Allentown to submit the application for One Hundred Forty Eight Thousand Seven Hundred Fifty Dollars (\$148,750.00) in Greenways, Trails, and Recreation funds to the Pennsylvania Department of Community & Economic Development.
