AN ORDINANCE

Amending the 2020 General Fund Budget to provide for a supplemental appropriation of Thirty Thousand (\$30,000) Dollars from the CDC Foundation to enhance partnerships between public health and public safety to support the initiatives to combat the opioid epidemic.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ALLENTOWN:

SECTION ONE: That City Council authorizes an increase to the unappropriated balance of the 2020 General Fund in the amount of Thirty Thousand (\$30,000) Dollars from the CDC Foundation.

The bill originated from the Department of Community Development, Bureau of Health. An award of new funds is being provided by the CDC Foundation to enhance partnerships between public health and public safety to support initiatives to combat the opioid epidemic.

Summary and Facts of the Bill

Amending the 2020 General Fund Budget to provide for a new appropriation of Thirty Thousand Dollars (\$30,000) from the CDC Foundation.

The purpose of this funding is to combat the opioid epidemic in Allentown through use of a toolkit to enhance iniatives between public health, public safety and other sectors.

A benefit of this Bill is the increased data analysis of overdose deaths in the city and the implmentation of new programming including an Overdose Fatality Review Team in order to decrease overdose deaths in the City of Allentown.

This Bill is congruent with the Health Bureau's mission to prevent disease and injury and to protect and promote the public's health.

Passing this Bill will not result in a financial cost to the City. \$30,000 in new expenditures will be placed in the 2020 budget, with corresponding revenues.
