AN ORDINANCE

Amending the 2020 General Fund Budget to provide for a supplemental appropriation of Seven Hundred Forty-Seven Thousand Two Hundred Sixty-Seven (\$747,267) Dollars from the Pennsylvania Department of Health, Bureau of Public Health Preparedness and Response for COVID-19 prevention, mitigation, response and recovery activities in the Public Health Emergency Preparedness Grant.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ALLENTOWN:

SECTION ONE: That City Council authorizes an increase to the unappropriated balance of the 2020 General Fund in the amount of Seven Hundred Forty-Seven Thousand Two Hundred Sixty-Seven (\$747,267) Dollars from the Pennsylvania Department of Health.

The bill originated from the Department of Community Development, Bureau of Health. An award of new funds is being provided by the Pennsylvania Department of Health, Bureau of Public Health Preparedness and Response for COVID-19 prevention, mitigation, response and recovery activities in the Public Health Emergency Preparedness grant.

Summary and Facts of the Bill

THIS IS AN EMERGENCY REQUEST. The purpose of the funding is to assist in covering expense for the Health Bureau's public health response to coronavirus disease (COVID-19). The specific public health preparedness tasks the bill seeks to accomplish are disease investigation and containment.

A benefit of this Bill is to enhance Allentown's ability to respond to COVID-19 that is both a global pandemic and local public health emergency. There is no down-side to this funding.

This Bill is congruent with the Health Bureau's mission to prevent disease and injury and to protect and promote the public's health.

Passing this Bill will not result in a financial cost to the City. \$747,267 in new expenditures will be placed in the 2020 budget, with corresponding revenues.

The benefits of the appropriation is to reimburse the City of Allentown for expenses related to the public health response to COVID-19.

The funds being allocated will be used to: 1) prevent the spread of the disease, implement mitigation measures, respond to and recover from the impacts of this disease; 2) plan for possible future vaccination efforts; 3) secure assistance with response and recovery efforts; 4) implement education and awareness campaigns; and 5) purchase equipment and supplies.

The funds are also needed to restore funding to other Health Bureau programs that purchased supplies that were needed immediately for the COVID-19 public health response. The programs included Injury Prevention (Program 2), Nutrition and Physical Activity (Program 3), and Communicable Disease (Program 4).
