AN ORDINANCE

Amending the 2020 General Fund Budget to provide for a supplemental appropriation of Twenty-One Thousand Three Hundred Six (\$21,306) Dollars from the Pennsylvania Department of Health, to support the Safe and Healthy Community Program including promotion and marketing for nutrition and physical activity and purchase of car seats for Allentown residents.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ALLENTOWN:

SECTION ONE: That City Council authorizes an increase to the unappropriated balance of the 2020 General Fund in the amount of Twenty-One Thousand Three Hundred Six (\$21,306) Dollars from the Pennsylvania Department of Health.

- **Summary and Facts of the Bill**

The supplemental funding is excess money the State offered Safe and Healthy Community (SHC) Grantees to support or expand current programming for the current grant year ending June 30th. The funding would help bolster specific programs contained within the SHC grant including promotion and marketing for nutrition and physical activity programs and the direct purchase of car seats for City of Allentown residents.

The Bill allows the expansion of current initiatives in place in the Health Bureau through supplemental funds. Expanded services include increased access to healthy foods through marketing and promotion of the distribution of fresh food to youth at local community sites and playgrounds through the summer meals program, additional technical assistance and support for all walking path JobClocks, keytabs and software for the Million Clicks walking program so as to ensure it remains free for residents to sign up, and the purchase of additional child car seats for city residents. All these programs are currently in place, are very popular amongst city residents and have proven effective in either increasing nutrition education, increasing activity or increasing traffic safety education.
