WHEREAS, Article 130.16 of the City's Administrative Code requires City Council approval by Resolution for the award of contracts or engagement of professional services.

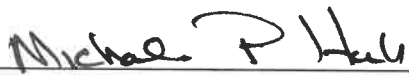

Contract Consideration: Pool Chemicals shall be purchased on an as needed basis at the unit prices identified in the attached bid tabulation. The City has allocated funds in the amount of \$30,000.00 to cover the cost of the pool chemicals for 2020. The total cost allocated for the LVCPC members, which is based on the estimated quantities provided prior to the solicitation process, the annual estimated awarded amount to these vendors is \$402,318.44, which is inclusive of the City's estimated sums as well as the estimated sums for the other Municipalities in the LVCPC. The

quantities provided in the bid are estimates, and as such, the actual cost of the chemicals may vary throughout the year based on the needs of the department.

- Description of project or scope of services to be provided:

The purpose of contract is to furnish and deliver SODIUM HYPOCHLORITE (BULK LOADS, DRUMS, AND DELDRUMS), CALCIUM CHLORIDE, SODIUM BICARBONATE & ALGAECIDE for each participating member of the Lehigh Valley Purchasing Council (LVCPC). Quantities are estimated based on last year's usage.

- Contract Term:

The Contract term shall commence upon council approval and shall cease March 30, 2021.

- List any renewal term options and duration of each renewal, if any:

Upon mutual agreement, this contract can be extended for up to three (3) additional one (1) year terms, if the vendor agrees to hold the prevailing prices

The LVCPC reserves the right to extend this contract for up to three (3) months. This extension will be utilized only to prevent a lapse on contract coverage, and only for the time necessary, up to three (3) months to issue a new contract.

- Maximum dollar value of all renewals provided for beyond the original term as if all renewals were exercised:
