AN ORDINANCE

Amending the 2020 Capital Projects Fund to provide for a supplemental appropriation of Two Hundred Eighty-Six Thousand Six Hundred Forty-Five Dollars (\$286,645) as a result of the annual receipt of capital improvement funds from the Trexler Trust as designated by Court Order.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ALLENTOWN:

SECTION ONE: That City Council authorizes an increase to the unappropriated balance of the Capital Fund in the amount of Two Hundred Eighty-Six Thousand Six Hundred Forty-Five Dollars (\$286,645).

SECTION TWO: That City Council authorizes a supplemental appropriation from the unappropriated balance of the Capital Fund to the following account:

Jordan Creek Greenway Trail

001-08-2206-2060-46 Other Contract Services \$ 86.645

Valania Park Renovations

001-08-2213-2060-46 Other Contract Services \$ 200,000

Total \$286,645

SECTION THREE: That this Ordinance will take effect ten (10) days after final passage.

SECTION FOUR: That all Ordinances inconsistent with the above provisions are repealed to the extent of their inconsistency.

Appropriate a total of \$286,645 to the Jordan Creek Greenways Trail (2206) and Valania Park (2213) capital projects. Appropriating these funds will complete the City's obligation to place 15% of the Trexler Trust award towards capital projects for the 2020 fiscal year.
