AN ORDINANCE

Amending the 2020 Capital Fund Budget to provide for a supplemental appropriation of One Million Dollars (\$1,000,000) as a result of a grant from the Pennsylvania Department of Transportation from their Transportation Alternatives Set-Aside (TASA) grant for Jordan Creek Greenway Trail.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ALLENTOWN:

SECTION ONE: That City Council authorizes an increase to the unappropriated balance of the 2020 Capital Fund in the amount of One Million Dollars (\$1,000,000) from the Pennsylvania Department of Transportation

Purpose of the ordinance is to appropriate the revenue and expenses for the \$1 million Transportation Alternatives Set-Aside (TASA) grant for Jordan Creek Greenway Trail construction from PennDOT. The project will construct a critical 2-mile segment of the Jordan Creek Greenway Trail - Allentown segment, which will connect Jordan Park, through Whitehall, and halting on the western end of Jordan Creek Greenway.
