Authorization for Engagement of Professional Services with <u>Environmental Systems Research Institute, Inc. (ESRI)</u>, in the amount of <u>\$26,500.00</u>. ESRI will be providing remote consulting services to assist the City with GIS operations around COVID-19.

**WHEREAS**, Article 130.16 of the City's Administrative Code requires City Council approval by Resolution for the award of contracts or engagement of professional services.

**WHEREAS**, it is the desire of the City of Allentown to enter into an agreement with the aforementioned Contractor, for the use and purpose indicated in supporting the Recommendation of Award of Bid:

Description of project or scope of services to be provided:

The City had requested ESRI's professional services to provide them with ArcGIS Disaster support consulting services for COVID-19. No quotes are necessary as ESRI is contracted with the State of Pennsylvania to provide various and sundry services some of which are not listed on said State Contract, however due to Article 7, "the Customer may request a quote for any new or unlisted ESRI offerings and issue a Purchase Order under this Contract. ESRI offerings governed by this Contract may be modified by letter signed by the parties indicating mutual written consent". The purchase of these services would be considered "new or unlisted ESRI offerings".

Moreover, **ESRI** will be providing remote consulting services to assist the City with GIS operations around COVID-19. These said services are more fully described in detail in the Contractor's proposal.

Contract Term:

The schedule will be mutually agreed upon between the City and ESRI within ten (10) days after the contract award.

ESRI will provide the City with twenty (20) hours of consulting support. All twenty (20) hour blocks of support must be expended within a period of six (6) months from when the valid Purchase Order is received. Said purchase order needs to be received by December 31, 2020.
